1. Terraflex, FIVB approved for 2 Volleyball Courts (2 colours) 36m x 21m = 756 sq. meter along with accessories.
2. TERRAFLEX, IHF Approved for 2 Hand ball Courts (3 colours) 40m x 20m
Total Area - 1149.45 sq. meter

Technical Specifications

1. Bidder must be registered.
2. Bidder shall provide the proof of previous experience of supplying the above materials to either IOA/Federations/Govt. Body/Semi Govt. Bodies at least once in last five years in case the bidder applies for 3 packages. If the bidder applies for one or two packages then the turn over shall be minimum 50.00 lakhs in a year.
3. The Bidder's financial turnover shall not be less than 1-00 crore in any year in preceding three years.
4. The Bidder has to submit a Bank Draft of Rs. 10,000/- towards Bid cost which shall be non refundable. Bank Draft shall be drawn in favour of Director, NGOC payable at Ranchi in any Nationalized/Scheduled Bank.
5. The bidder can bid for one two or all the three packages.
6. In case of bidding only for package-I the bidder has to pay Earnest Money of Rs. 3.00 lakhs as Bank Draft in favour of Director, NGOC payable at Ranchi.
7. In case of Bidding only for Package-II the bidder shall have to submit a Bank Draft for Rs. 1.50 lakhs as earnest money drawn in favour of Director, NGOC payable at Ranchi.
8. In case of Bidding only for Package-III the bidder shall have to submit a Bank Draft of Rs. 4.00 lakhs as Earnest Money drawn in favour of Director, NGOC payable at Ranchi.

9. Accordingly if the bidder bids for more than one package then Bank Draft of such value shall be submitted adding the above package wise rates. To be more explicit Earnest Money for Package-I & II shall be 4.50 lakhs. Package-I & III shall be 7.00 lakhs. Package- I, II & III shall be 8.50 lakhs.
10. Bank Drafts shall be of any Nationalized or Scheduled Bank.
11. Earnest money & Bid amount shall be kept in the Technical Bid envelope.
12. The bidder must be an authorized dealer of the concerned manufacturer. Proof regarding this has to be given in the Technical bid.
13. The bidder shall have to produce Income Tax Paid/Commercial Taxes paid proofs.
14. Quoted materials shall conform to International Federations standard. Appropriate proof regarding this shall have to be produced.
15. The manufacturing company shall be ISO approved.
16. The flooring (Terraflex or Monduflex) should have been done by the concerned bidder at least in one Stadium in India.

Financial Criteria

The Price shall be quoted for individual item. Any ambiguous price quoted shall be rejected. The price shall be For at Ranchi. No extra transportation cost shall be paid.

The Price Quotation shall be in the Financial Bid envelope.

Bid System

Two bid system shall be applied. Technical Bid & Financial Bid. Both shall be in separate sealed envelopes. Both the envelopes shall be kept inside a third envelope. The bidders who shall qualify in the Technical Bid, the Financial Bids of such bidders shall be opened.

Other Conditions

1. The decision of the Tender Committee shall be final & binding on the tenderers.
2. The successful bidder shall have to deposit security money (10 percent of the bid value) either as Bank Draft or Bank Guarantee. Then the Earnest Money shall be returned.

3. Earnest Money of unsuccessful bidders shall be returned.
4. Tender Opening date & time shall be communicated so that the bidders can remain present.
5. The successful tenderer after submitting security money shall have to enter in to an Agreement with the Director, NGOC. Then only work order shall be issued.
6. The bidder has to supply the material within three months of date of work order.
7. In case of Imported items L.C. of appropriate value shall be opened.
8. 70 percent of the bid value shall be released after supply & receipt of materials.
9. 30 percent of the bid value shall be released only after quality checking by the experts from respective National Federations/IOA.
10. During Games period one technical representative of the bidder shall be present who shall ensure smooth functioning of the supplied materials.

Director, NGOC, Ranchi invites tender for Sports Goods as mentioned in above three packages. The bid shall be received up to 06.07.09 till 3.00 P.M and shall be opened on 06.07.09 at 3.30 P.M. in office of NGOC Secretariat, Morabadi, Ranchi. Late submission of tenders shall not be accepted.
